

## 5 Steps to Obtaining Your Hawaii Journeyman Plumber's License

### Step 1. Sign up for the exam.

**Qualifications:** Eligibility to sit for a license qualification exam is determined by the State of Hawaii Board of Electricians and Plumbers. For an application and detailed information about eligibility requirements, write or phone:

To be licensed in Hawaii you need:

- proof of workers' compensation insurance
- bodily injury liability – \$100,00 each person, \$300,000 each occurrence
- property damage liability – \$50,000 each occurrence
- place of business in Hawaii – post office box not accepted
- pass an exam on business, law, and a trade

**Exam Fees:** The fee for taking the exam is \$80.

### Step 2. Purchase the required books for your exam.

You must purchase these documents and books in preparation for the exam and bring them with you on testing day for the open book portions of the exam.

### Step 3. Start studying!

To fully prepare for your exam it is best to thoroughly study the required documents and books, as well as any recommended studying materials. The amount of preparation time needed will be different for each individual. Be sure to allow yourself enough time to fully prepare for the exam.

#### Step 4. Follow the rules.

Candidates should bring the following items to the examination:

- Admission Letter;
- Current, government-issued photo ID, such as a driver's license or passport;
- Silent, battery powered or solar powered calculator. No tape-producing calculators are allowed;
- Two sharpened No. 2 pencils;
- Approved reference materials.

#### Step 5. Good luck on the exam!

It is best that you arrive at the examination site at least 30 minutes prior to your scheduled exam time on the day of testing. The exam has two parts -- Part One is the Business and Law and Part Two concerns the specific trade you want to be licensed in. The **Business and Law** part of the exam covers:

The **Journeyman Plumber's Exam** is an open *Code-book*, multiple-choice test consisting of 100 questions. The test covers the following subject areas:
